# Terms of Agreement

I hereby apply to become an Independent Representative of the Sensaria (hereinafter "Company") marketing program. As an Independent Representative (IR), I understand and agree that:

1. I am of legal age in the state in which I enter this Agreement. I shall become a Company IR upon acceptance of this application by the Company.
2. The Company may amend the marketing program and policies at its sole discretion. Notice of any amendments shall be disseminated in any commercially reasonable fashion, including but not limited to posting on the Company's official web site, distribution via e-mail, in company newsletters, and/or inserts into product shipments. Amendments shall be effective 30 days after notice is issued.
3. I will review and follow the Company's marketing program and policies. I acknowledge that the marketing program and policies are incorporated into this Agreement in their present form and as modified from time to time by the Company at its sole discretion.
4. The term of the IR Agreement is one year from the date on which my application is accepted by the Company. I understand that if I wish to continue my IR status, I must renew my IR Agreement annually at a fee of \$60.00.
5. I understand that I am entitled to cancel participation in the marketing program at any time and for any reason upon written notice to the Company. Upon receipt of written notification of cancellation or termination, if I so request, the Company will repurchase mandatory sales kit materials in accordance with its policies.
6. Upon acceptance of this Application by the Company, I will be an independent contractor responsible for my own business and not an employee of the Company. I WILL NOT BE TREATED AS AN EMPLOYEE IN REGARD TO ANY LAWS COVERING EMPLOYEES, INCLUDING BUT NOT LIMITED TO THE FEDERAL UNEMPLOYMENT TAX ACT, THE SOCIAL SECURITY ACT, THE FEDERAL UNEMPLOYMENT TAX ACT, INCOME TAX WITHHOLDING AT SOURCE OR FOR ANY FEDERAL OR STATE TAX LAWS. It is my responsibility to pay self-employment, state and federal income taxes as required by law.
7. I will not use the Company's trade name and/or trademark except in the advertising provided to me by the Company or in other advertising without prior written approval by the Company.
8. I understand that if I recruit other IRs, I must fulfill the obligation of performing a bona fide supervisory, distributing and selling function in the sale or delivery of product to the ultimate consumer and in the training of those recruited. I must also have ongoing contact, communication, and management supervision with my sales organization. Examples of such supervision may include, but are not limited to: newsletters, written correspondence, personal meetings, telephone contact, voice mail, electronic mail, training sessions, and accompanying individuals to training functions.
9. As an IR, I shall have the right to sell the services and products offered by the Company in accordance with the Company's marketing program and to develop an organization of downline Independent Representatives in accordance with the Company's policies. The position of IR does not constitute the sale of a franchise. This Agreement is not intended and shall not be construed to create a relationship of employer – employee, agency, partnership, or joint venture between any IR, recruiter and/or the Company.

As an independent contractor, I shall:

- Abide by any and all federal, state, county and local laws, rules and regulations pertaining to this Agreement and/or the acquisition, receipt, holding, selling, distributing or advertising of Company products.
  - At my own expense, I shall make, execute or file all reports and obtain such licenses as are required by law or public authority with respect to this Agreement and/or the receipt, holding selling, distributing or advertising of Company products.
  - Be solely responsible for declaration and payment of all local, state and federal taxes as may accrue because of my activities in connection with this Agreement.
10. The Company may take disciplinary action against me, as described in its policies, if I engage in any act or omission that, in the sole discretion of the Company, damages the Company's name or goodwill, or engage in any illegal or unethical conduct, violate this Agreement and/or the Company's policies, or misrepresent the Company's products or business opportunity. If I am voluntarily or involuntarily terminated for any reason, I waive any and all rights to my former downline, including property rights (if any exist), and I further waive all claims to any and all income derived from sales volume generated by such downline organization.
  11. I waive and release the Company, its directors, officers, shareholders, employees, assigns, and agents (collectively referred to as "affiliates"), from all claims for consequential and exemplary damages arising from or relating to any breach of this Agreement. I further agree to release the Company and its affiliates from all liability arising from or relating to the promotion or operation of my business and any activities related to it (by way of example, but not limited to, the presentation of the Company products or the compensation plan, the operation of a motor vehicle, the lease of meeting or training facilities, etc.), and agree to indemnify the Company for any liability, damages, fines, penalties, or other awards arising from any negligent, illegal, or unauthorized conduct that I undertake in the pursuit of my business.
  12. I authorize the Company to use my name, photograph, personal story, and/or likeness in advertising or promotional materials, and I waive all claims for remuneration for such use. The Company reserves the right to communicate directly to my customers and/or email addresses compiled through my Sensaria business.
  13. This Agreement, along with the policies and compensation plan, in their current form and as may be modified by the Company in the future at its discretion, constitutes the entire Agreement between myself and the Company and no other additional promises, representations, guarantees or agreements of any kind shall be valid unless in writing. If any provision of this Agreement or the policies are held to be void or voidable by a court of competent jurisdiction, only such void or voidable provision shall be severed, and all remaining provisions shall remain in full force and effect.
  14. This Agreement shall be governed by the laws of the State of Washington, without regard to principles of conflicts of laws, and all claims, disputes and other matters between the parties of this Agreement shall be brought in King County, State of Washington, or in the U.S. District Court in Seattle, WA. I agree that any claim or cause of action seeking damages for any breach of this Agreement must be brought within one year from the date of the breach, and I waive all rights to any other applicable statute of limitations.
  15. I acknowledge that I have read and understand and agree to the terms set forth in this Agreement.
  16. This Agreement is not in force until accepted by the Company.
